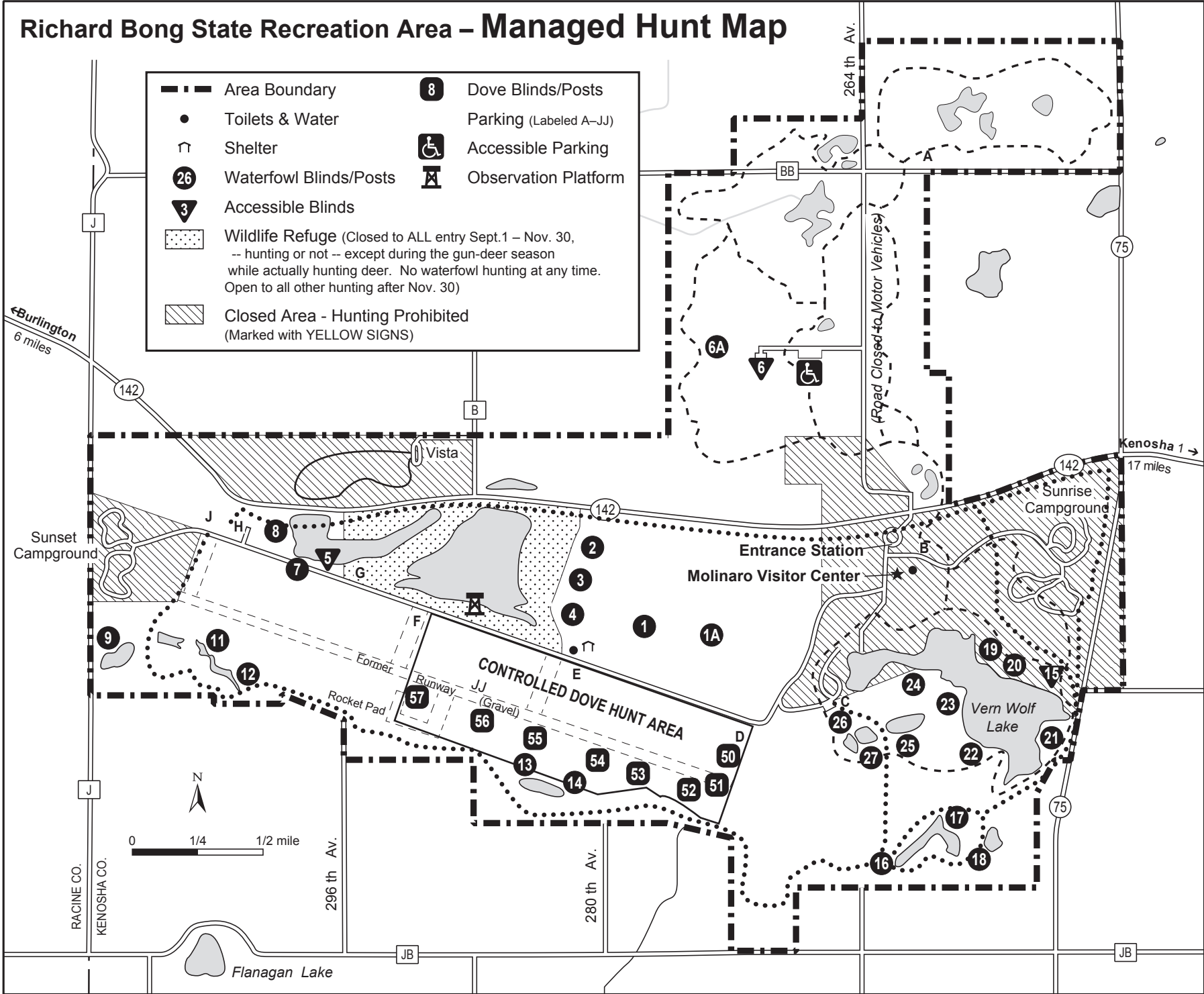


Richard Bong State Recreation Area – Managed Hunt Map

PERMIT REQUIREMENTS

- Wisconsin State Park vehicle admission Sticker
- Daily Hunting Permits
 - During stocking- pheasant \$12.00 adult / \$7.00 Jr.
 - After stocking- pheasant \$5.00/day.
 - Pheasant permits must be purchased from attendant at the office.
 - All other game- \$1.00 hunting permit
 - Self-registration allowed.
- Hunters must fill in the Cust. ID# on the pheasant permit.
- Harvested pheasants must be immediately validated by slitting the pheasant permit where indicated
- Bong hunting permits are limited; first come, first served.
- All appropriate Wisconsin hunting licenses, stamps, permits required per statewide regulations.

GENERAL HUNTING INFORMATION

- Nontoxic shot required for all migratory game birds (waterfowl, mourning dove, etc.) except woodcock.
- Discharged shells/cartridges must be removed.
- All dogs must be leashed outside of legal hunting hours.
- Hunting from service roads and trails is permitted.
- Parking in Lot JJ is prohibited during the pheasant season.
- Waterfowl and dove hunters at blinds/posts must sign in at the Entrance Station prior to hunting
- No entry earlier than one hour prior to opening of hunting

Hunting hours for all game during *Pheasant Season**:

Date	Open	Close	Daily Bag Limit for Pheasant
Opening Day	Per Small Game Regulations		1 of Either Sex
2 nd Day of Season	9:00 A.M.	2:00 P.M.	1 of Either Sex
3 rd Day ⇒ Close of Season	9:00 A.M.	2:00 P.M.	2 of Either Sex

***Exception:** Waterfowl and Deer hunting **open** per statewide regulations. Gun Deer **closes 2p.m.** Waterfowl north of HWY 142 **closes 2p.m.** Waterfowl south of Hwy 142 and Archery Deer close per statewide regulations all season. All other hunting closes at 2pm. **Outside of pheasant season, all hunting opens/closes per statewide regulations.**

WATERFOWL HUNTING

- South of Hwy 142- Hunting permitted from state blinds or posts ONLY (2 hunters maximum per blind/post). Hunters are permitted to set up their own portable blinds on #'s **1A, 23 and 24**, within ten feet of post. NOTE: Posts 23 and 24 are on the water requiring use of a boat.
- North of Hwy 142- Jump shoot hunting only. NO blinds available. In this area shooting ends at 2:00 pm each day.

MOURNING DOVE HUNTING

CONTROLLED MOURNING DOVE HUNT AREA

- The 'Controlled Mourning Dove Hunt Area' includes numbered posts in the area between the Special Use Zone Road and the mowed boundary (approximately 100 yards south of the gravel runway) and extends from the service road at Lot D to the service road at Lot F. (See map on the reverse side).
- First registered hunter has sole rights to post.
- You may only hunt Mourning Dove from within 10 feet of the numbered posts.
- Maximum of 3 people per Mourning Dove post.
- You may not discharge a weapon towards the ATV trails or a neighboring post.
- No waterfowl hunting at dove posts.

OTHER AREAS

- All other hunting areas are open to mourning dove hunters, no sign-in needed.

Be sure to obtain all pertinent Wisconsin hunting regulations pamphlets before hunting this season.

RESERVATION PROCEDURES (Waterfowl)

- A drawing will be held the 4th Monday of August for waterfowl reservations from applications that were submitted August 1st through the 4th Sunday of August. Applications can again be submitted after September 1 and will be approved on a first come, first served basis. Applications must be received a minimum of two days prior to the hunting date.
- Waterfowl reservation charge is \$3.00 for each date requested. Waterfowl reservations can be made on a DNR reservation form in person at RBSRA or by mail between August 1 and the 4th Sunday of August. Beginning September 1 reservations may be made by phone during office hours M-F 9am-4pm. (Visa or Master Card required).
- Each hunter may make no more than 5 reservations.
- No individual may submit more than one application for a single date.
- Confirmed reservations cannot be changed or transferred to another hunter.
- Please mark on the reservation card hunting time requested. (All day/ Morning only.)
- Reservations will be confirmed by mail or phone.

This form summarizes RBSRA specific hunting regulations, but is not a complete set of laws.
